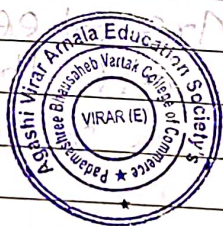
At the end, secretary of committee Mrs. Sheetal Koradkar gave vote of thanks & conclude the meeting at 12 p.m.

4) It was seen that some students faced technical issues. But overall everything else went smoothly as planned in previous meeting.

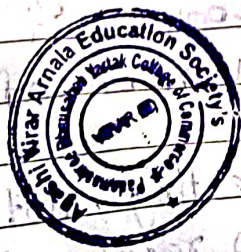
5) As college's reopen, it's important that precautions are taken both inside and outside the classroom to prevent the spread of COVID-19.


- Physical distancing at school

1) As it was discussed earlier, we make sure that washroom are kept clean. We prioritize our concern for hygiene.


2) Morning assembly gave students opportunity to share their thoughts in front of collage, students can overcome stage fear.

3) All the competitions we conducted offline went smooth.


4) As it was discussed earlier to provide free coaching for singing, dance etc. Maximum students participated and got chance to explore there skills and

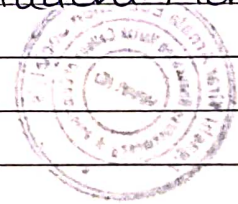

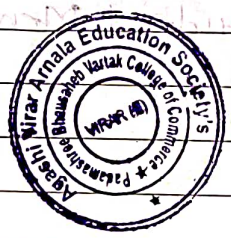
The meeting commenced with the chairperson welcoming all attendees and introducing the purpose of forming the grievance redressal cell committee.
